2. INTRODUCTION AND BACKGROUND

The Mekong River Commission (MRC) was established by the 1995 Agreement on Co-operation for the Sustainable Development of the Mekong River Basin, between the governments of Cambodia, Lao PDR, Thailand and Viet Nam. The role of the MRC is to coordinate and promote cooperation in all fields of sustainable development, utilization, management and conservation of the water and related resources of the Mekong River Basin.

The MRC Secretariat (MRCS) is the operational arm of the MRC. It provides technical and administrative services to the Joint Committee and the Council to achieve the MRC's mission.

The MRC has a vision for an economically prosperous, socially just and environmentally sound Mekong River Basin. Various MRC Basin Development Strategies have proritized social and economic development inclusiveness, within which gender is a key issue. MRC Gender Policy has the goal to mainstream gender perspectives in all MRC development efforts, ensuring that all MRC development programmes benefit men and women equally, in accordance with their different needs, and with the input and equal participation of men and women at all levels.

The MRC Basin Development Strategy 2021-2030, approved by the MRC Council in 2020, has integrated gender & vulnerability as cross-cutting issue in its all five strategic priorities. Gender and vulnerability is mainstreamed through out the MRC planned areas of of work outlined in the MRC Strategic Plan 2021-2025. A Gender Action Plan 2021-2025 provides guidance for this mainstreaming work together with how the mainstreaming will be monitored in the planning period. For 2021-2025, gender mainistreamig at MRC focuses on data collection, monitoring, briefings for policy responses, gender analysis of accessibility and opportunities

Explicit gender and vulnerability activities have been defined for most outcomes, with budget allocation, under each Strategic Priority of the MRC SP 2021-2025.

In the MRC Multi-year workplan 2021-2022, 14 gender related tasks have been identified and will be implemented over the period of 2021 and 2022, in relation to MRC functions such as water resources manaegement and planning, flood and drought forecasting and early warning, environmental assets and vulnerable social groups, coordinated operating rules and governance arrangements on dam operations, and gender-responsive organisational development

3. OBJECTIVES OF THE CONSULTANCY

The specific objectives of this assignment to be achieved by Nov 2021 are as follows:

- Provide inputs regarding gender dimension and sensitivity during drafting process of funding application for global funds such as GEF, GCF, AF, etc
- Provide inputs to updated TORs and JDs of MRCS staff
- Support/facilitate discussions on G &V approach and specific training whenever required for MRCS and MCs
- Review the draft report on gender and vulnerability aspects of the water, food and energy nexus in the Mekong Basin and related data/information gaps and plans for filling the gaps, a draft expected in Oct 2021
- Review and inputs on the socio-economic data collection MOUs with Member Countries and other related documents and policy recommendation notes, under DAGAP implementation, expected starting in November 2021
- Support implementation, monitoring and reporting of the GAP 2021-2022 tasks in the MWP 2021-2022
- Support the MRC Secretariat improving its gender mainstreaming as appropriate

4. EXPECTED RESULTS:

Based on the above objectives of the assignment, the followings are the key expected outputs of this consultancy:

- Better understanding for the MRC Secretariat and its divisions the key aspects of gender and vulnerabilities in water resources management and planning;
- 2. Better engagement and coordination among the MRCS divisions on gender and vulnerability through workshops, meetings and other exchanges;
- 3. Gender mainstreaming is achieved in the MRCS workplan and results is reflected in the annual progress reporting; and

- Liaise with relevant partners and stakeholders including Development Partners, Civil Society Organizations, to explore data and information on gender and vulnerability, and cooperation opportunities to better understand gender and vulnerability issues, and capture relevant knowledge, data and information;
- Provide inputs and suggestion to MRCS Divisions on relevant reports and activities relating to gender and vulnerability aspects of water, food and energy security, data availability and gaps, and collection needs; and
- Support implementation, monitoring & evaluation and reporting to ensure gender dimension sensitivity being implemented as cross-cutting issues in MRC core funtions.
