Mandate



- CC occurred and will continue. LMB countries - among the most vulnerable countries in the world
- Adaptation to CC impacts: recognized as urgently needed
- MRC CCAI was asked to formulate and implement Mekong Adaptation Strategy and Action Plan (MASAP). MASAP formulation and implementation: integrated in MRC SP 2011-2015 and 2016-2020
- The importance of MRC's works on CC adaptation: reaffirmed in both the Hua Hin Declaration (2010) and the Ho Chi Minh City Declaration (2014). The Heads of the Governments emphasized the need for MRC to focus and prioritize on researching and addressing the threats to livelihoods posed by CC and preparing for CC adaptation measures, including the MASAP

Purpose



- The MASAP is a statement of the Lower Mekong Basin (LMB) countries (Cambodia, Lao PDR, Thailand and Vietnam) setting out the strategic priorities and actions at basin level to address climate change risks on the basin and strengthen basin-wide resilience.
- The MASAP, while strengthen basin-wide resilience, will contribute to ensuring sustainable development of the Mekong River Basin in line with the 1995 Agreement on the Cooperation for the Sustainable Development of the Mekong River Basin (the 1995 Mekong Agreement).

Aligned Vision



- The MASAP is formulated following the MRC's vision of an economically prosperous, socially just, environmentally sound and climate resilient Mekong River Basin.
- The MASAP contributes to ensuring that people, communities, businesses, and other organizations be able to cope with current climate variability as well as adapt to future climate change, preserving development gains, and minimizing damages.

Added values



- The added values of the MASAP are ensured by addressing critical CC adaptation aspects that need transboundary cooperation and by enhancing the capacity of MCs in implementing their own national strategies
- The critical transboundary aspects that MASAP addresses are:
 - The need to address the climate and water linkage at basin level using IWRM approach.
 - The need to address transboundary issues associated with climate change adaptation.
 - The need to support riparian countries to implement their adaptation strategies and plans at national, regional and international level.

The MASAP in brief



- A tool to mainstream adaptation planning at national and regional level
- An opportunity to seek additional funding for adaptation measures firstly at the regional scale but also at national scale to address transboundary climate change issues
- An orientation (through the CCAI Basin-wide assessment) for the identification of concrete relevant adaptation measures
- A strategy aligned to but complementing the already existing national strategy and plans as well as the Nationally Determined Contribution on CC adaptation

Strategic Guidance



MRC's strategic priorities and actions in climate change and adaptation should:

- *Support sustainable development pathways, especially having broad socioeconomic benefits and rationale and ensuring resilience to shocks* whether they be due to climate change or other causes
- *Support improved governance and strengthened institutions* that allow for participatory approaches and enhanced decision-making capacity for individuals and communities.

Strategic Guidance (cont.)



- *For adaptation measure, it needs to identify opportunities:*
 - Opportunities: direct effects of CC - very much context specific and vary greatly in different areas in the LMB.
 - Developing adaptation options through its integrated approach provides opportunities for linkages and synergies in adaptation with other themes. It also comprises opportunities for improving transboundary cooperation
 - Implementing adaptation measures provides opportunities to attract funding and opportunities to improve livelihood
- *Be flexible and scalable* - the direction and magnitude of change: uncertainty. It is important that communities can deal with change regardless of how it manifests itself and can rapidly scale-up the response.

The 7 strategic priorities, the pillars of the MASAP



1. Mainstreaming CC into regional and national policies, programs and plans;
2. Regional and international cooperation and partnership on adaptation;
3. Implementation of transboundary, gender sensitive adaptation options;
4. Access to adaptation finance;
5. Monitoring, data collection and sharing;
6. Capacity development for climate change adaptation strategies and plans;
7. Outreach of MRC products on climate change and adaptation.

MASAP's strategic priority n#1: Mainstreaming CC into regional and national policies, programs and plans



- Any water related strategies and long-term programmes in the LMB should consider such modifications due to CC and should address them in the planned actions.
- Opportunities as arising from the integrated climate change assessments and the subsequent analysis should be included in the process of mainstreaming
- Aligned to this strategic priority, at regional level mainstreaming awareness of CC impacts and associated measures to the MRC sectoral strategies developed during 2016-2020, the NIPs and the BDS 2021-2025 should be done.

MASAP's strategic priority n#1 : Mainstreaming CC into regional and national policies, programs and plans (cont.)



- To ensure consistency regarding future climate projections between the MRC sectoral strategies 2016-2020, the NIPs, the BDS 2021-2025 and the MASAP, all should be based on the CC scenarios
- Mainstreaming at the national level to enhance adaptive capacity of MCs, through mainstreaming of strategic priorities and actions of the MASAP into national adaptation projects and programmes as well as streamlining the NIPs with the MASAP.
- To ensure that the adaptation strategy remains relevant under new insights and developments in CC and its effects, regular updating of the MASAP is needed.

MASAP's strategic priority n#2: Regional and international cooperation and partnership on adaptation



- Transboundary cooperation: necessary and beneficial in adapting to CC.
- More efficient and effective adaptation, among others, by pooling available data, models, scenarios and resources and enlarges the planning space for locating adaptation measures
- Demands not only strong political will, but also a solid institutional basis both at the national and regional level
- Strengthen the links between the national CC focal agencies, related line agencies and the NMCs: amplify the cooperation between MRC and the MCs in CC adaptation.

MASAP's strategic priority n#2: Regional and international cooperation and partnership on adaptation (cont.)



- Cooperation between MRC and other regional coordination mechanisms like ASEAN and LMC: yield improved consistency between the regional responses, avoid duplication of efforts, and help strengthen the efforts.
- Exchange of good practices and experiences with CC communities at both regional and international level.
- Strengthening the link and partnerships with international / regional communities and making such partnership more sustainable, all can be institutionalized within the MRC.
- Funding is required for implementation of the MASAP. Networking with IFIs and other donors: to mobilise funds for the intended projects.

MASAP's strategic priority n#3: Enable implementation of transboundary and gender sensitive adaptation measures



- Implementation of transboundary adaptation measures: fundamental to ensure progress towards the MASAP vision.
- Relevant projects: further identified and described and subsequently implemented
- For adaptation measures to be effective and efficient, they need to reflect differentiated vulnerabilities and needs among the different groups.
- Gender and age awareness as well as equity will be considered.
- Implementation of the PINs is highly dependent on securing resources. MRC will be in contact with various organizations that are likely to be able to provide support

MASAP's strategic priority n#4: Access to adaptation finance



- Specific attention is needed regarding finance to secure sufficient funding for implementation of the MASAP
- MRC will engage with DPs and international funding mechanisms to mobilize funding for implementation of the PINs
- Various international funding mechanisms exist to support countries in implementing CC adaptation initiatives. MRC will identify and analyse the relevant mechanisms and will keep track and inform MCs of the changes in the mechanisms and the finance landscape.

MASAP's strategic priority n#5: Monitoring, data collection and sharing



- Improved information: needed to reduce the uncertainty associated with risk assessment, vulnerability assessment and progress and effectiveness of the adaptation strategy.
- Data collection and sharing: needed to provide for the necessary information at the basin scale.
- The CCA indicators of the basin-wide monitoring and reporting system will need to be completed and improved in order to provide the relevant information to identify status and trends in CC effects and adaptation

MASAP's strategic priority n#5: Monitoring, data collection and sharing (cont.)



- Collection of the data by the MCs to assess the indicators and sharing of the data with MRC is needed to ensure that sufficient information is available to make informed decisions and to be able to improve the MASAP in its next planning cycle
- The collected information will be reported and compiled into the updated overviews of status and trends of the CCA indicators.

MASAP's strategic priority n#6: Capacity development for climate change adaptation strategies and plans



- Capacity building is needed to enhance national and regional capacity on development of CC adaptation strategies and plans.
- A range of guidelines, methods and tools related to CC adaptation developed. MRCS will provide support in applying these ones.
- For instance, developing a CC impact and vulnerability assessment by sharing its approach, experience and the available methods and tools.
- MRC will share, on request, its approach and experience in developing the MASAP with the MCs to support them in developing national and sub-national adaptation strategies.

MASAP's strategic priority n#7: Outreach of MRC products on climate change and adaptation



- To ensure MRC findings and products on CC adaptation are known and used in the MCs and the outsider, activities to communicate and disseminate need to identify
- The MRC website and Data Portal contains information on the activities and results of the work on CC: maintained and updated when relevant
- News and updates will be announced through social media like the MRC Facebook. Through this channel, also the public at large can gain more awareness of the CC impact and adaptation.
- The process and results of the MASAP will be presented and discussed at relevant events including the Mekong Forum to gain further experience.

Mekong River Commission Council	Provide strategic guidance to implementation and promotion of the MASAP at a high-level to all relevant national and regional development initiatives
Mekong River Commission Joint Committee (JC)	Provide direct implementation guidance to implementation and promotion of the MASAP at senior-level to all relevant national and regional development initiatives
Mekong River Commission Secretariat (MRCS)	Facilitate, support and monitor the implementation of the MASAP and regularly report to the Joint Committee and Council
National Mekong Committees Secretariat	Act as liaison between MRC and the respective national climate change committees and mainstream climate change adaptation into the National Indicative Plans (NIPs)
National Line Agencies including National Climate Change Focal Agencies	Develop and implement transboundary – influential climate change adaptation projects
