A firm will be selected under the Quality and Costs Based Selection (QCBS) procedures described in this Request for Proposal (RFP), following the MRC regulations detailed in its Procurement Manual.¹

SECTION II

INSTRUCTION TO BIDDERS

1. Proposal to be considered

- a. **Eligibility:** Proposals which comply with the conditions and terms as stipulated in the Request for Proposal documents will be considered.
- b. **Conflict of Interest:** MRC considers a conflict of interest to be a situation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, contractual obligations, or compliance with applicable laws and regulations.
- c. **Amendment of RFP:** At any time before the submission of Proposals, MRC may amend the RFP by issuing an addendum in writing or by standard electronic means. Consultants having informed MRC about their intention to submit a proposal will be informed directly. Any changes will be posted on MRC's website. MRC reserves the right to extend the submission deadline if the amendment is substantial.
- d. **Cancelation:** The MRCS reserves the right to cancel this Request for Proposal at any time.

2. Procurement package

The RFP consists of a single package.

3. Clarification

Request for clarifications should be made in writing and sent to the Procurement Unit at procurement@mrcmekong.org .

The request for clarifications should be submitted no later than seven (7) days prior to the tender submission deadline.

All MRCS replies will be in writing and posted on the MRC's website: www.mrcmekong.org under the section "Procurement Notices".

4. Language of the Proposal

The Proposals prepared by the bidders and all correspondence and documents relating to the Proposal exchanged by the bidders and the MRCS shall be written in English. Any printed literature furnished by the bidders may be written in another language so long as accompanied by an English translation of its pertinent passages in which case, for purposes of interpretation of the Proposal, the English translation shall govern.

5. Proposal Currency

All prices shall be quoted in US dollars.

6. Period of Validity of Proposals

Proposal shall remain valid for **120 days** after the date of Proposal submission prescribed by the MRC.

7. Submission of Proposals

7.1 Sealing and Marking of Proposals

The proposals shall be submitted in one outer sealed envelope containing two separate sealed envelopes, one envelope containing the Technical Proposal(s) and one envelope containing the Financial Proposal(s). The outer envelope shall be clearly marked "**Proposal RFP25-010: Travel Management Services for the Mekong River Commission Secretariat**".

- **DO NOT OPEN BEFORE THE SUBMISSION DEADLINE**". The two sealed inner envelopes shall be marked "Technical Proposal (s)" and "Financial Proposal (s)" respectively. The sealed envelope shall be addressed to the Mekong River Commission Secretariat at the following address:

Alternatively, bidders are allowed to submit their proposals by email. Bidders who intend to submit electronic proposals must follow the following submission instructions:

- Bidders can submit a proposal by email. The proposal shall be separated in two files: one for technical proposal and one for financial proposal.
- The file for the **financial proposal** shall be **protected by a password** which shall be kept with the bidders. If the company passed the technical requirement threshold MRC would then request the password to open the financial proposal file. However, if the company loses the password or in case the file could not be opened the MRC would not assume responsibility.
- The file shall be in the form of MS Word or MS Excel (MS Office 2007 at least) or PDF version 7.
- Please send the electronic proposal to procurement@mrcmekong.org
- Please be aware that bids or proposals emailed to the MRCS will be rejected if they are received after the deadline for bid submission. As an email may take some time to arrive after it is sent, especially if it contains a lot of information, we advise all bidders to send email submissions well before the deadline.
- Maximum size for electronic submission: The maximum size per email that MRC can receive is **5MB**. Bidders may need to split proposals into parts to fit this limit.

Please note that the proposal must arrive in the aforementioned mailbox before the submission deadline.

7.2 Deadline for Submission of Proposals

The deadline for submission of the bids is **no later than 15:00** local time on **12 February 2026**.

Proposals should contain details of the criteria for the selection mentioned below. The bid shall be prepared in English and one (1) original and five (5) copies must be submitted. The sealed bid envelope must be received by the Mekong River Commission Secretariat on or before the hour and date fixed for receipt of bids, in accordance with the invitation for bids.

7.3 Confirmation of Participation

The company who is willing to submit their proposal should confirm by email to the MRCS procurement unit at least 7 days before the deadline for submission of proposals.

8. Late Proposals

Any proposal received by MRCS's procurement unit after the deadline for submission of Proposals will be rejected.

9. Criteria for Selection.

The Method of Selection is **QCBS (Quality and Costs Based Selection)**.

a. Preliminary Examination Criteria

Proposals will be examined to determine whether they are complete and submitted in accordance with RFP requirements as per the criteria below on a **Pass/Fail basis**.

Bidders not meeting the following criteria will not be evaluated further.

b. Evaluation of Technical Proposal:

The evaluation panel will fully evaluate the Technical Proposals. The panel will determine which of the Technical Proposals pass the minimum agreed technical score specified in Section IV.

After the evaluation of Technical Proposals has been completed, the MRCS will notify those Consultants whose proposals did not pass the minimum technical score or were considered to be non-responsive to the TOR.

c. Evaluation of Financial Proposal:

The financial evaluation shall be based on the lowest price of those bidding firms which submitted responsive Technical Proposals. The formula for determining the financial scores is the following:

$S_f = 100 \times F_m / F$, in which S_f is the financial score, F is the lowest price, and F_m is the price of the proposal under consideration.

d. Final evaluation and negotiations:

The final ranking of the proposals will be based on the quality of technical proposals and lowest cost.

The total score will be calculated as the weighted sum of the technical and financial scores, with the weights given to the technical and financial scores being:

70/30 where the technical proposal = 70 and the financial proposal = 30.

With regard to contract negotiations, the MRCS reserves the right to invite the next-ranked firm to negotiate, if negotiations with the first-ranked firm do not result in a contract.

Bidders who pass the minimum score, but are unsuccessful based on the calculation of the technical and financial scores, will be notified after the contract with the winner has become effective.

11. Association

Proposals submitted by an association of two or more firms as partners shall comply with the stipulations:

- (i) The Proposal shall be signed so as to be legally binding on all partners.
- (ii) One firm shall be nominated as the lead firm of the association.
- (iii) The lead firm shall be liable for the execution of the Contract in accordance with the Contract terms.
- (iv) The lead firm shall receive instructions for and on behalf of any and all partners.

12. Rejection of proposals

Should any Proposal fail to comply with the terms and conditions stipulated in this Request for Proposals, or be incomplete, conditional or obscure, or contain additions not called for or irregularities of any kind, or does not respond to important aspects of the RFP, and particularly the Terms of Reference or if it fails to achieve the minimum technical score, it may be rejected as non-responsive.

A. Service Summary

B. Background

The Mekong River Commission (MRC) was established by 1995 Mekong Agreement between the governments of Cambodia, Laos, Thailand and Vietnam. The role of the MRC is to co-ordinate and promote co-operation in all fields of sustainable development, utilization, management and conservation of the water related resources of the Mekong River Basin. The mission of the MRC is to promote and coordinate sustainable management and development of water and related resources for the countries' mutual benefit and the people's well-being.

The MRC Secretariat is the operational arm of the MRC. It provides technical and administrative services to the Joint Committee and the Council to achieve the MRC's mission.

The JC Preparatory meeting for 22nd MRC Council, paragraph 64, the meeting supported the decision to have only one office in the future and suggested that the specific location should be further discussed. After consulting and working with JC members by communication official letters and reference to the official letter from MRCS sent to TNMC JC Chair on 19 September 2016 to have one Headquarter (HQ) of the MRC Secretariat in Vientiane.

In order to achieve cost efficiency from economies of scale while ensuring outstanding quality of service, the Office of the MRC Secretariat intends to enter into contracts with **one Travel Agent** to serve the travel needs and service requirement of MRCS.

TRAVEL, as referred to in this Terms of Reference (TOR), shall apply to all international and domestic movements or journey in both offices of MRC staff from one place to another for official business purposes. These official purposes include, but may not be limited, to the following:

1. Official missions, meetings and various national and international events;
2. Interviews of applications/ candidates for employment;
3. Appointment and repatriation of staff, family members and consultants
4. Home leaves, emergency travels.

The travel agents are expected to provide full and comprehensive travel management services to HQ and RFMMC with full service.

C. Project description:

In view of the foregoing, the MRC is therefore hereby undertaking a solicitation of bid proposals from travel agents who are interested to provide various travel services regularly required by the MRCS offices. The successful bidders shall be identified thereafter, upon satisfactory evaluation of relevant past performance.

Upon entering into a contract with MRCS, the successful travel agent in Vientiane shall appoint a Travel Assistant attached to the Administration Division on behalf of the MRCS.

The contract shall not impose a minimum guarantee on volume sales on the part of the MRCS. The contract will cover the provision of travel management and related services hereafter referred to as "Travel Management Services". Travel Management services shall include, but not be limited to: airline ticketing and airport transfer, hotel reservations, and related services (visa services, airport pick-up, travel insurance, hotel accommodations, car rental arrangements, and ticket delivery) for travel plans and preparation of suitable itineraries (including alternative routings, departures and arrivals) at the lowest cost for staff member and/or their dependents (for purpose of official and non-official travels) and consultants, government officials and participants attending meetings or on official business for the MRCS.

D. Qualifications of the successful vendor:

The Travel Agents shall have its office in Vientiane, all the necessary equipment and facilities, and shall employ a sufficient number of experienced and professionally trained travel experts and staff to handle minimum requirements of the MRCS system. The successful Travel Agents who will be contracted to serve the needs of the MRCS system shall have the following minimum qualification:

- Maintains a good task record in serving international organizations and embassies;
- Accredited by Consular Offices and Embassies, Vientiane International Airport Sales Agent for international airlines
- Employs competent and experienced travel consultants, especially in ticketing and fare computations, as evidenced by their track record in their Curriculum Vitae;
- Employees who are proficient in written and spoken English; service minded, have good communication skills, good personality, ticket certificate
- Capable of deploying motorized messenger

- Willing and able to guarantee the delivery of services to both offices in accordance with the performance standards required.
- Company Profile, which should not exceed fifteen pages, including history of the entity, key personnel, highlights of services provided in the past, and certificate of incorporation verifying legal status/capacity;
- List of major clients with contact information with reference letters from minimum two clients, that the agent has had business with;
- Financial documents (audited/certified financial statements or equivalent) for the last two years (in 2023 & 2024).
- Copy of Company and staff IATA accreditation certificate or confirmation document that company is in the process of IATA accreditation if available;
- CV of all personnel, as required under Minimum Required Personnel, highlighting their experience, as relevant to the TOR requirements.
- Reference letter from IATA Member Airlines - if available
- List of IATA-approved ticketing system (Global Distribution System – GDS) used/licensed to the Vendor including documentary evidence. – if available
- Official Letter of Appointment as local representative, if Bidder is submitting a Bid in behalf of an entity located outside the country

E. Services required by MRC:

The successful vendors shall provide full, prompt, accurate and expert international travel products and services to officers/staff of the MRC system, their dependents and other travellers authorized/accredited under the MRC system, in accordance with the MRC policies, procedures and guidelines. The products and services required by the MRCS shall basically include, but not be limited to, the following:

1. General

The Travel Agents should provide travel services from 8:00 am to 4:30 pm during working days. In addition the Travel Agents shall provide for 24 hours a day emergency service, as well as for services during weekends and official holidays where an emergency travel service is required one of the travel agent's employees shall always be reachable by phone and available to provide service to the MRCS. The contact phone number and email address will be given on an answering machine;

The official travel requirements shall be accorded the highest priority and, therefore, the travel agent shall ensure that servicing non-MRC does not delay, impede or frustrate the travel agents timely and effective processing of MRC official travel;

Much of the official travel must be organized on short notice, thereby placing a premium on efficiency and rapid communication in handling all travel related matters. Furthermore, in carrying out its diverse worldwide operations, the MRC need not only to arrange of travel of

its Vientiane based staff, but also for the travel of new staff, participants in meetings, and staff other parts of the world.

2. Reservation and ticketing

Upon receipt of advice from a designated Travel Assistant, the travel agent shall immediately make bookings and prepare appropriate, all confirmed if possible, itineraries and formal quotations based on the most economical fare and the most direct and convenient routing;

In the event that required travel arrangements can not be confirmed, the travel agent shall notify the requesting party of the problem and present three alternative routing/quotations for the traveller's consideration;

For wait-listed booking, the travel agent shall provide regular feedback on status of flight and continuously endeavor to secure confirmation;

The travel agent shall promptly issue and deliver accurately printed tickets and detailed itineraries, (in printed and electronic format) showing the accurate status of the airline and hotel reservations on all segments of the journey;

The travel agent shall accurately advise the relevant MRCS of ticketing deadline and other relevant information every time reservations are made, in order to avoid cancellations of bookings;

The travel agent shall reconfirm and revalidate airline tickets, reissue tickets which are returned as a result of changed routing or fare structures;

The travel agent shall be given complete copies of the various MRC travel policies and procedures and shall be fully familiar and comply with these policies and procedures for all official travel;

The travel agent shall provide all official travellers with last seat availability, advance seat assignments and advance boarding passes on all airlines for which the travel agent can offer these services. The travel agent is expected to expand these services, as they become available on additional carriers.

3. Other services

The travel agent:

- Shall provide travellers with advice on necessary health requirements, including types of inoculations and vaccinations either required or suggested for travel to certain countries or areas; visa requirements, immigration clearance, foreign exchange control regulation and other government restrictions.
- Shall indicate any special features, programmes, or services that would be beneficial to the MRC and its travellers (e.g. lost baggage follow-up, preferred seating

- arrangements, special meal request, travel insurance premiums depending on length of travels and limit of indemnity).
- Shall provide support for MRC meetings and workshops in regards to flight reconfirmation, reservations and or change of the reservations during the course of the meeting may be requested.
- May be required to liaise with the airlines to provide free or discounted accommodation for any traveller who is required wait in transit for unreasonably long waiting hours (e.g. more than five hours).
- Shall provide the service of the hotel booking in other countries, transportation, visa services and others as required

4. Travel documentation

The travel agent shall ensure that all traveling staff has complete travel documents required for their journeys, sufficiently before departure;

5. Airfare and airline routing/itineraries

The travel agent shall propose fares and airline routing, and guarantee that it shall obtain the lowest available airfare for the journey concerned. Such journeys shall be the most direct and economical routing;

MRC reserves the right to purchase the air ticket from other travel agents if there are proofs that the other agencies can supply the same type of air tickets and services with lower costs.

The travel agent shall ensure that tickets issued are in accordance with entitlements as per MRCS standard travel policies, and as may be prescribed in the travel authorization;

The travel agent shall assist, upon the MRC request, the MRC Travel Assistant in OSV or Admin Assistant in OSP in negotiating with airlines on preferred carrier fares for the MRC system, (and if successful, load such fares in travel agent's computerized reservation system for use in auto-ticketing);

Advise the MRC on Market practices and trends that could result in further savings for the MRC, including the use of corporate travel booking tools with automated travel policy compliance and enforcement, and travel management reporting.

6. Travel information/advisories

The travel agent:

- Shall inform travellers, upon booking confirmation, of flight/ticket restrictions, involuntary stop-over, hidden stops, and other possible inconveniences of the itinerary;
- Shall provide travellers with online, offline relevant information on official destinations (e.g. airport transfer/land transportation facilities, local point of interest, currency

restrictions/regulations, health advisories, security advisories, weather conditions, etc.);

- Shall endeavour to notify travellers of airport closures delayed or cancelled flights, security procedures, health precautions, as well as other changes that will affect or will require preparations from the travellers, sufficiently before departure time; and quick reference for requested destination.

7. Flight cancellations/rebooking and refunds

The travel agent :

- Shall process duly authorized flight changes and cancellations when and as required and taking care that in such cases, cancellation fees and charges imposed by the airlines are avoided;
- Shall immediately process airline refunds for cancelled travel requirements and unutilized pre-paid tickets, and credit these to the MRC as expeditiously as possible;
- In case of flight delay the travel agent shall provide alternative solution such as rebook the next flight or transfer to nearby airports.
- Shall refund tickets to the MRC and not the individual traveller. Under no circumstances should ticket proceeds be refunded to the traveller;
- Limit refund charges at airline rates only, i.e., no additional charges will accrue to the travel agent.

8. Management reporting system

The travel agent shall submit to the MRC the following reports and documents at any time upon request by the MRC;

Daily, weekly, or monthly production statistics with comparative figures if applicable (month to month, year on year);

Monthly carrier-route-fare analysis and volume of business figures;

Changes and updates on airline rates, promotions, policy changes, etc. immediately upon the travel agent's receipt of the advice;

Saving achieved from the carrier's lowest available "Y" fare and "ticket refund" status.

9. Traveller's profiles

The travel agent shall maintain computerized profiles of all frequent travellers, as designated or defined from time to time by the MRC, setting forth the travellers' preferences regarding airlines, hotels. Seating and meal requirement, passport and credit card information, and such other information as is useful to facilitate such travellers travel arrangement.

10. Ticket delivery

The travel agent shall deliver tickets, based upon proper authority from the MRC in case of official travel.

Delivery of airline tickets preferably within twenty-four hours (24 hours for PTA ticket) of receipt of the staff Travel Authorizations (TA), or earlier depending on need and seat assignment on flights and issuance of boarding passes, where possible. Price and itinerary of long haul flight shall be submitted for approval prior to the issuance of the air ticket within 72 hours from the date of information.

Reconfirmation and revalidation of airline tickets, re-issued tickets which are returned as a result of changed routing or fare structures and printed itineraries showing complete information on status of reservations on all carriers and hotels

Timely notification to travellers of airport closing, cancellations or delays in flights, trains, buses and obtain any reimbursement which may be due on account of cancelled or reissued reservation and/or tickets.

11. Service standards

The travel agent provides the Secretariat with all required computer equipment to support the computerized reservation system software sufficiently for the performance of the service under the agreement.

The MRC provides a three month trial period of internet connection starting from the date of service commencement. The parties will review the actual usages during this period and finalize the agreed condition before the end of the trial period.

The MRC provides free local telephone calls for all business contacts under this Agreement to the travel agent main office. Calls to other area codes will be upon prior approval by the MRC on a case by case basis.

The travel management services, as may be requested by the MRC or any of its Associated Agencies provided by the travel agent shall include:

Onward air fare, rail and ground transportation; whenever possible, discount rates public carriers on a world-wide basis;

Investigation on any complaints from travellers and follow up the recovery of lost baggage.

The travel agent shall be equipped with a fully automated accounting system interfaced with the computerized reservation system with the MRC's requirements.

The qualifications and experience of any staff whom the travel agent may assign to perform the travel management services hereunder shall be the same, or better, as those specified in the travel agent proposal and shall be approved and accepted by the staff. The travel agent shall provide the staff with the home address and 24/7 emergency telephone number of one key personnel among its staff to assist the MRC during emergencies outside of the normal business hours.

The travel agent shall neither seek nor accept instruction from any authority external to the MRC or the associated agencies in connection with the performance of this agreement. The travel agencies and shall fulfil its commitments with the fullest regard for the interests of the MRC and the associated agencies.

The MRC will submit to the travel agent a Travel Authorization indication the maximum entitlement (mode and class) permitted to traveller for such travel. All TA shall be in writing, signed by an Authorized Representative. The MRC shall not be responsible for any travel management services undertaken by the travel agent without such TA.

It is required that the travel agent provides the office in the MRC premises, the MRC then provide suitable office space in accordance with the conditions for use of office space, to the travel agent for the sole purpose of performing its obligations under this agreement. In full consideration for the office space and the services provided by the MRC the total amount of rent shall be zero, no utilities cost will be charged to the travel agent.

The travel agent shall retain all standard and override commissions earned on the sale of air transportation except as provided hereunder, such commissions except as provided hereunder, shall constitute the sole compensation for the travel management services provided under this agreement.

The MRC shall be responsible for payment of airline ticket and associated expenses as may be expressly provided in the TA, together with any charge incurred and for which the Employer is responsible. The contractor shall, however, use its best efforts to minimize the imposition of charge and penalties.

The Travel Unit is required to summarize and consolidate all invoices on a monthly basis and submit them to the Administrative Unit for payment processing.

Special Service

- The travel agent support MRC travelers at Wattay International Airport for Emergency issue: Problem with Check - In Immediately issue new ticket ...etc
- 3-5 yrs. Experiences on site travel services (outsource service) provide info on similar type of services.
- Provide 5-10 years of experience for a Travel Consultant to be on-site (CV of staff must certify two IATA certifications to assist with on-site rotation support.)
- Minimum cash flow on bank account to support MRC account (1 M USD) based on travel amount.
- Be able to provide instant train tickets service
- 24-Hour Hotline Available.
- O.T.A Service.

12. Supplier relations

The travel agent shall not favour any particular carrier when making reservations and shall maintain excellent relations with all carriers for the benefit of the MRC. The travel agent shall undertake to provide contact between the MRC Travel Assistant or Admin Assistant and, *inter alia*, airports, airlines, hotels and shall when required arrange for meeting between the MRC and such entities for the benefit of the MRC.

13. Performance Evaluation and Review

The travel shall meet periodically with the MRC to discuss issues of mutual concern, to review the Travel Agent's performance and to discuss improvements which the travel agent

or the MRC should make in order to achieve more effective travel management and greater savings. The travel agent shall arrange meetings twice a year to discuss travel updates and other travel matters with the MRC. The travel agent shall make the MRC aware immediately of major industry changes. Which have a broad impact on its travel policy or procedures

MRC shall have the right to perform pre or post travel audits, through an independent auditor, in order to assess the selected Travel Agent compliance with the lowest cost fare. In the event that the Travel Agent has not obtained the lowest cost fare, the Travel Agent shall refund to MRC the difference between the price paid by MRC and the price of the lowest cost fare which was available.

14. Travel Agent's quality control

The travel agent shall establish and operate to monitor on a regular and continual basis the quality of travel services provided to the MRC. These procedures shall include a self-inspection system covering all the services to be performed under the contract and shall include a method for monitoring, identifying and correcting deficiencies in the quality of service furnished to the MRC. The MRC shall be notified of any deficiencies found and corrective action taken; such actions shall be included in the travel agent's narrative report required.

The MRC shall reserve the right to conduct their own quality control surveys among frequent travellers.

The travel agent warrants that the personnel assigned to handle the MRC travel arrangements shall have a strong travel experience and shall constantly be trained to be kept up to date.

1. Definitions

1.1 The following words and expressions shall have the meanings hereby assigned to them:

- (a) "MRC" refers to the Mekong River Commission
- (b) "Contract" means the Contract Agreement entered into between the Purchaser and the Supplier, together with the Contract Documents referred to therein, including all attachments, appendices, and all documents incorporated by reference therein.
- (c) "Contract Documents" means the documents listed in the Contract Agreement, including any amendments thereto.
- (d) "Contract Price" means the price payable to the Supplier as specified in the Contract Agreement, subject to such additions and adjustments thereto or deductions therefrom, as may be made pursuant to the Contract.
- (e) "Day" means calendar day.
- (f) "Completion" means the fulfillment of the Related Services by the Supplier in accordance with the terms and conditions set forth in the Contract.
- (g) "GCC" means the General Conditions of Contract.
- (h) "Goods" means all of the commodities, raw material, machinery and equipment, and/or other materials that the Supplier is required to supply to the Purchaser under the Contract.
- (i) "Purchaser's Country" is the country specified in the TOR
- (j) "Purchaser" means the entity purchasing the Goods and Related Services, as specified in the TOR.
- (k) "Related Services" means the services incidental to the supply of the goods, such as insurance, installation, training and initial maintenance and other such obligations of the Supplier under the Contract.
- (l) "SCC" means the Special Conditions of Contract.

3.1 The MRC requires Bidders, Suppliers, Contractors, and Consultants to observe the highest standard of ethics during the procurement and execution of such contracts. In pursuit of this policy, the MRC:

(a) defines, for the purposes of this provision, the terms set forth below as follows:

(i) “corrupt practice” means the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the procurement process or in contract execution; and

(ii) “fraudulent practice” means a misrepresentation or omission of facts in order to influence a procurement process or the execution of a contract;

(iii) “collusive practice” means a scheme or arrangement between two or more Bidders, with or without the knowledge of the Borrower, designed to establish bid prices at artificial, non competitive levels; and;

(iv) “coercive practice” means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or affect the execution of a contract;

(b) will cancel the portion of the loan allocated to a contract if it determines at any time that representatives of the Borrower or of a beneficiary of the loan engaged in corrupt, fraudulent, collusive or coercive practices during the procurement or the execution of that contract, without the Borrower having taken timely and

appropriate action satisfactory to the MRC to remedy the situation;

- (c) will sanction a firm or individual, including declaring them ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that they have, directly or through an agent, engaged, in corrupt, fraudulent, collusive or coercive practices in competing.
- (d) will have the right to require that Suppliers to permit the MRC to inspect their accounts and records and other documents relating to the bid submission and contract performance and to have them audited by auditors appointed by the MRC.

4. Interpretation 4.1 If the context so requires it, singular means plural and vice versa.

4.2 Incoterms

- (a) Unless inconsistent with any provision of the Contract, the meaning of any trade term and the rights and obligations of parties thereunder shall be as prescribed by Incoterms.
- (b) The terms EXW, CIP, FCA, CFR and other similar terms, when used, shall be governed by the rules prescribed in the current edition of Incoterms specified in the SCC and published by the International Chamber of Commerce in Paris, France.

4.3 Entire Agreement

The Contract constitutes the entire agreement between the Purchaser and the Supplier and supersedes all communications, negotiations and agreements (whether written or oral) of the parties with respect thereto made prior to the date of Contract.

4.4 Amendment

No amendment or other variation of the Contract shall be valid unless it is in writing, is dated, expressly refers to the Contract, and is signed by a duly authorized representative of each party thereto.

4.5 Nonwaiver

- (a) Subject to GCC Sub-Clause 4.5(b) below, no relaxation, forbearance, delay, or indulgence by either party in enforcing any of the terms and conditions of the Contract or the granting of time by either party to the other shall prejudice, affect, or restrict the rights of that party under the Contract, neither shall any waiver by either party of

any breach of Contract operate as waiver of any subsequent or continuing breach of Contract.

(b) Any waiver of a party's rights, powers, or remedies under the Contract must be in writing, dated, and signed by an authorized representative of the party granting such waiver, and must specify the right and the extent to which it is being waived.

4.6 Severability

If any provision or condition of the Contract is prohibited or rendered invalid or unenforceable, such prohibition, invalidity or unenforceability shall not affect the validity or enforceability of any other provisions and conditions of the Contract.

5. Language

5.1 The Contract as well as all correspondence and documents relating to the Contract exchanged by the Supplier and the Purchaser, shall be written in English. Supporting documents and printed literature that are part of the Contract may be in another language provided they are accompanied by an accurate translation of the relevant passages in English, in which case, for purposes of interpretation of the Contract, this translation shall govern.

5.2 The Supplier shall bear all costs of translation to the governing language and all risks of the accuracy of such translation, for documents provided by the Supplier.

6. Joint Venture, Consortium or Association

6.1 If the Supplier is a joint venture, consortium, or association, all of the parties shall be jointly and severally liable to the Purchaser for the fulfillment of the provisions of the Contract and shall designate one party to act as a leader with authority to bind the joint venture, consortium, or association. The composition or the constitution of the joint venture, consortium, or association shall not be altered without the prior consent of the Purchaser.

7. Eligibility

7.1 All Goods and Related Services to be supplied under the MRC Contract shall be complied or better quality of required specification

8. Notices

8.1 Any notice given by one party to the other pursuant to the Contract shall be in writing to the address specified in the SCC. The term "in writing" means communicated in written form with proof of receipt.

8.2 A notice shall be effective when delivered or on the notice's effective date, whichever is later.

9. Governing Law

9.1 The Contract shall be governed by and interpreted in accordance with the laws of the Purchaser's Country, unless otherwise specified in the SCC.

10. Settlement of Disputes	<p>10.1 The Purchaser and the Supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.</p> <p>10.2 If, after twenty-eight (28) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Purchaser or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given. Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract. Arbitration proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.</p> <p>10.3 Notwithstanding any reference to arbitration herein,</p> <ul style="list-style-type: none"> (a) the parties shall continue to perform their respective obligations under the Contract unless they otherwise agree; and (b) the Purchaser shall pay the Supplier any monies due the Supplier.
11. Scope of Supply	11.1 The Goods and Related Services to be supplied shall be as specified in the Schedule of Requirements.
12. Delivery and Documents	12.1 Subject to GCC Sub-Clause 32.1, the Delivery of the Goods and Completion of the Related Services shall be in accordance with the Delivery and Completion Schedule specified in the Schedule of Requirements. The details of shipping and other documents to be furnished by the Supplier are specified in the TOR.
13. Supplier's Responsibilities	13.1 The Supplier shall supply all the Goods and Related Services included in the Scope of Supply in accordance with GCC Clause 11, and the Delivery and Completion Schedule, as per GCC Clause 12.
14. Contract Price	14.1 Prices charged by the Supplier for the Goods supplied and the Related Services performed under the Contract shall not vary from the prices quoted by the Supplier in its bid, with the exception of any price adjustments authorized in the SCC.
15. Terms of Payment	<p>15.1 The Contract Price, including any Advance Payments, if applicable, shall be paid as specified in the SCC.</p> <p>15.2 The Supplier's request for payment shall be made to the Purchaser in writing, accompanied by invoices describing, as</p>

appropriate, the Goods delivered and Related Services performed, and by the documents submitted pursuant to GCC Clause 12 and upon fulfillment of all other obligations stipulated in the Contract.

15.3 Payments shall be made promptly by the Purchaser, but in no case later than sixty (60) days after submission of an invoice or request for payment by the Supplier, and after the Purchaser has accepted it.

15.4 The currencies in which payments shall be made to the Supplier under this Contract shall be those in which the bid price is expressed.

15.5 In the event that the Purchaser fails to pay the Supplier any payment by its due date or within the period set forth in the SCC, the Purchaser shall pay to the Supplier interest on the amount of such delayed payment at the rate shown in the SCC, for the period of delay until payment has been made in full, whether before or after judgment or arbitration award.

16. Taxes and Duties

16.1 For goods manufactured outside the Purchaser's Country, the Supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the Purchaser's Country.

16.2 For goods Manufactured within the Purchaser's country, the Supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted Goods to the Purchaser.

16.3 If any tax exemptions, reductions, allowances or privileges may be available to the Supplier in the Purchaser's Country, the Purchaser shall use its best efforts to enable the Supplier to benefit from any such tax savings to the maximum allowable extent.

17. Performance Security

17.1 If required as specified in the SCC, the Supplier shall, within twenty-eight (28) days of the notification of contract award, provide a performance security for the performance of the Contract in the amount specified in the SCC.

17.2 The proceeds of the Performance Security shall be payable to the Purchaser as compensation for any loss resulting from the Supplier's failure to complete its obligations under the Contract.

17.3 As specified in the SCC, the Performance Security, if required, shall be denominated in the currency(ies) of the Contract, or in a freely convertible currency acceptable to the Purchaser; and shall be in one of the format stipulated by the Purchaser in the SCC, or in another format acceptable to the Purchaser.

17.4 The Performance Security shall be discharged by the Purchaser and returned to the Supplier not later than twenty-eight (28) days following the date of Completion of the Supplier's performance obligations under the Contract, including any warranty obligations, unless specified otherwise in the SCC.

18. Copyright

18.1 The copyright in all drawings, documents, and other materials containing data and information furnished to the Purchaser by the Supplier herein shall remain vested in the Supplier, or, if they are furnished to the Purchaser directly or through the Supplier by any third party, including suppliers of materials, the copyright in such materials shall remain vested in such third party

19. Confidential Information

19.1 The Purchaser and the Supplier shall keep confidential and shall not, without the written consent of the other party hereto, divulge to any third party any documents, data, or other information furnished directly or indirectly by the other party hereto in connection with the Contract, whether such information has been furnished prior to, during or following completion or termination of the Contract. Notwithstanding the above, the Supplier may furnish to its Subcontractor such documents, data, and other information it receives from the Purchaser to the extent required for the Subcontractor to perform its work under the Contract, in which event the Supplier shall obtain from such Subcontractor an undertaking of confidentiality similar to that imposed on the Supplier under GCC Clause 19.

19.2 The Purchaser shall not use such documents, data, and other information received from the Supplier for any purposes unrelated to the contract. Similarly, the Supplier shall not use such documents, data, and other information received from the Purchaser for any purpose other than the performance of the Contract.

19.3 The obligation of a party under GCC Sub-Clauses 19.1 and 19.2 above, however, shall not apply to information that:

- (a) the Purchaser or Supplier need to share with the MRC or other institutions participating in the financing of the Contract;
- (b) now or hereafter enters the public domain through no fault of that party;
- (c) can be proven to have been possessed by that party at the time of disclosure and which was not previously obtained, directly or indirectly, from the other party; or
- (d) otherwise lawfully becomes available to that party from a third party that has no obligation of confidentiality.

19.4 The above provisions of GCC Clause 19 shall not in any way modify any undertaking of confidentiality given by either of the parties hereto prior to the date of the Contract in respect of the Supply or any part thereof.

19.5 The provisions of GCC Clause 19 shall survive completion or termination, for whatever reason, of the Contract.

20. Subcontracting

20.1 The Supplier shall notify the Purchaser in writing of all subcontracts awarded under the Contract if not already specified in the bid. Such notification, in the original bid or later shall not relieve the Supplier from any of its obligations, duties, responsibilities, or liability under the Contract.

20.2 Subcontracts shall comply with the provisions of GCC Clauses 3 and 7.

21. Specifications and Standards

21.1 Technical Specifications and **Drawings**

- (a) The Goods and Related Services supplied under this Contract shall conform to the technical specifications and standards mentioned in Section VI, Schedule of Requirements and, when no applicable standard is mentioned, the standard shall be equivalent or superior to the official standards whose application is appropriate to the Goods' country of origin.
- (b) The Supplier shall be entitled to disclaim responsibility for any design, data, drawing, specification or other document, or any modification thereof provided or designed by or on behalf of the Purchaser, by giving a notice of such disclaimer to the Purchaser.
- (c) Wherever references are made in the Contract to codes and standards in accordance with which it shall be executed, the edition or the revised version of such codes and standards shall be those specified in the Schedule of Requirements. During Contract execution, any changes in any such codes and standards shall be applied only after approval by the Purchaser and shall be treated in accordance with GCC Clause 32.

22. Packing and Documents

22.1 The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the Contract. During transit, the packing shall be sufficient to withstand, without limitation, rough handling and exposure to extreme temperatures, salt and precipitation, and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final

destination and the absence of heavy handling facilities at all points in transit.

22.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract, including additional requirements, if any, specified in the SCC, and in any other instructions ordered by the Purchaser.

23. Insurance

23.1 Unless otherwise specified in the SCC, the Goods supplied under the Contract shall be fully insured—in a freely convertible currency from an eligible country—against loss or damage incidental to manufacture or acquisition, transportation, storage, and delivery, in accordance with the applicable Incoterms or in the manner specified in the SCC.

24. Transportation

24.1 Unless otherwise specified in the SCC, responsibility for arranging transportation of the Goods shall be in accordance with the specified Incoterms.

25. Inspections and Tests

25.1 The Supplier shall at its own expense and at no cost to the Purchaser carry out all such tests and/or inspections of the Goods and Related Services as are specified in the SCC.

25.2 The inspections and tests may be conducted on the premises of the Supplier or its Subcontractor, at point of delivery, and/or at the Goods' final destination, or in another place in the Purchaser's Country as specified in the SCC. Subject to GCC Sub-Clause 25.3, if conducted on the premises of the Supplier or its Subcontractor, all reasonable facilities and assistance, including access to drawings and production data, shall be furnished to the inspectors at no charge to the Purchaser.

25.3 The Purchaser or its designated representative shall be entitled to attend the tests and/or inspections referred to in GCC Sub-Clause 25.2, provided that the Purchaser bear all of its own costs and expenses incurred in connection with such attendance including, but not limited to, all traveling and board and lodging expenses.

25.4 Whenever the Supplier is ready to carry out any such test and inspection, it shall give a reasonable advance notice, including the place and time, to the Purchaser. The Supplier shall obtain from any relevant third party or manufacturer any necessary permission or consent to enable the Purchaser or its designated representative to attend the test and/or inspection.

25.5 The Purchaser may require the Supplier to carry out any test and/or inspection not required by the Contract but deemed necessary to verify that the characteristics and performance of the Goods comply with the technical specifications codes and standards under the Contract, provided that the Supplier's

reasonable costs and expenses incurred in the carrying out of such test and/or inspection shall be added to the Contract Price. Further, if such test and/or inspection impedes the progress of manufacturing and/or the Supplier's performance of its other obligations under the Contract, due allowance will be made in respect of the Delivery Dates and Completion Dates and the other obligations so affected.

25.6 The Supplier shall provide the Purchaser with a report of the results of any such test and/or inspection.

25.7 The Purchaser may reject any Goods or any part thereof that fail to pass any test and/or inspection or do not conform to the specifications. The Supplier shall either rectify or replace such rejected Goods or parts thereof or make alterations necessary to meet the specifications at no cost to the Purchaser, and shall repeat the test and/or inspection, at no cost to the Purchaser, upon giving a notice pursuant to GCC Sub-Clause 25.4.

25.8 The Supplier agrees that neither the execution of a test and/or inspection of the Goods or any part thereof, nor the attendance by the Purchaser or its representative, nor the issue of any report pursuant to GCC Sub-Clause 25.6, shall release the Supplier from any warranties or other obligations under the Contract.

26. Liquidated Damages

26.1 Except as provided under GCC Clause 31, if the Supplier fails to deliver any or all of the Goods by the Date(s) of delivery or perform the Related Services within the period specified in the Contract, the Purchaser may without prejudice to all its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to the percentage specified in the SCC of the delivered price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the percentage specified in those SCC. Once the maximum is reached, the Purchaser may terminate the Contract pursuant to GCC Clause 34.

27. Warranty

27.1 The Supplier warrants that all the Goods are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials, unless provided otherwise in the Contract.

27.2 Subject to GCC Sub-Clause 21.1(b), the Supplier further warrants that the Goods shall be free from defects arising from any act or omission of the Supplier or arising from design, materials, and workmanship, under normal use in the conditions prevailing in the country of final destination.

27.3 Unless otherwise specified in the SCC, the warranty shall remain valid for twelve (12) months after the Goods, or any

portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the SCC, or for eighteen (18) months after the date of shipment from the port or place of loading in the country of origin, whichever period concludes earlier.

27.4 The Purchaser shall give notice to the Supplier stating the nature of any such defects together with all available evidence thereof, promptly following the discovery thereof. The Purchaser shall afford all reasonable opportunity for the Supplier to inspect such defects.

27.5 Upon receipt of such notice, the Supplier shall, within the period specified in the SCC, expeditiously repair or replace the defective Goods or parts thereof, at no cost to the Purchaser.

27.6 If having been notified, the Supplier fails to remedy the defect within the period specified in the SCC, the Purchaser may proceed to take within a reasonable period such remedial action as may be necessary, at the Supplier's risk and expense and without prejudice to any other rights which the Purchaser may have against the Supplier under the Contract.

28. Patent Indemnity

28.1 The Supplier shall, subject to the Purchaser's compliance with GCC Sub-Clause 28.2, indemnify and hold harmless the Purchaser and its employees and officers from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of any nature, including attorney's fees and expenses, which the Purchaser may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright, or other intellectual property right registered or otherwise existing at the date of the Contract by reason of:

- (a) the installation of the Goods by the Supplier or the use of the Goods in the country where the Site is located; and
- (b) the sale in any country of the products produced by the Goods.

Such indemnity shall not cover any use of the Goods or any part thereof other than for the purpose indicated by or to be reasonably inferred from the Contract, neither any infringement resulting from the use of the Goods or any part thereof, or any products produced thereby in association or combination with any other equipment, plant, or materials not supplied by the Supplier, pursuant to the Contract.

28.2 If any proceedings are brought or any claim is made against the Purchaser arising out of the matters referred to in GCC Sub-Clause 28.1, the Purchaser shall promptly give the Supplier a

notice thereof, and the Supplier may at its own expense and in the Purchaser's name conduct such proceedings or claim and any negotiations for the settlement of any such proceedings or claim.

28.3 If the Supplier fails to notify the Purchaser within twenty-eight (28) days after receipt of such notice that it intends to conduct any such proceedings or claim, then the Purchaser shall be free to conduct the same on its own behalf.

28.4 The Purchaser shall, at the Supplier's request, afford all available assistance to the Supplier in conducting such proceedings or claim, and shall be reimbursed by the Supplier for all reasonable expenses incurred in so doing.

28.5 The Purchaser shall indemnify and hold harmless the Supplier and its employees, officers, and Subcontractors from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of any nature, including attorney's fees and expenses, which the Supplier may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright, or other intellectual property right registered or otherwise existing at the date of the Contract arising out of or in connection with any design, data, drawing, specification, or other documents or materials provided or designed by or on behalf of the Purchaser.

29. Limitation of Liability

29.1 Except in cases of criminal negligence or willful misconduct,

- (a) the Supplier shall not be liable to the Purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the Supplier to pay liquidated damages to the Purchaser and
- (b) the aggregate liability of the Supplier to the Purchaser, whether under the Contract, in tort or otherwise, shall not exceed the total Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the supplier to indemnify the purchaser with respect to patent infringement

30. Change in Laws and Regulations

30.1 Unless otherwise specified in the Contract, if after the date of 28 days prior to date of Bid submission, any law, regulation, ordinance, order or bylaw having the force of law is enacted, promulgated, abrogated, or changed in the place of the Purchaser's country where the Site is located (which shall be deemed to include any change in interpretation or application

by the competent authorities) that subsequently affects the Delivery Date and/or the Contract Price, then such Delivery Date and/or Contract Price shall be correspondingly increased or decreased, to the extent that the Supplier has thereby been affected in the performance of any of its obligations under the Contract. Notwithstanding the foregoing, such additional or reduced cost shall not be separately paid or credited if the same has already been accounted for in the price adjustment provisions where applicable, in accordance with GCC Clause 14.

31. Force Majeure

- 31.1 The Supplier shall not be liable for forfeiture of its Performance Security, liquidated damages, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- 31.2 For purposes of this Clause, "Force Majeure" means an event or situation beyond the control of the Supplier that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the Supplier. Such events may include, but not be limited to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- 31.3 If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

32. Change Orders and Contract Amendments

- 32.1 The Purchaser may at any time order the Supplier through notice in accordance GCC Clause 8, to make changes within the general scope of the Contract in any one or more of the following:
 - (a) drawings, designs, or specifications, where Goods to be furnished under the Contract are to be specifically manufactured for the Purchaser;
 - (b) the method of shipment or packing;
 - (c) the place of delivery; and
 - (d) the Related Services to be provided by the Supplier.
- 32.2 If any such change causes an increase or decrease in the cost of, or the time required for, the Supplier's performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or in the Delivery/Completion Schedule, or both, and the Contract shall accordingly be

amended. Any claims by the Supplier for adjustment under this Clause must be asserted within twenty-eight (28) days from the date of the Supplier's receipt of the Purchaser's change order.

32.3 Prices to be charged by the Supplier for any Related Services that might be needed but which were not included in the Contract shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the Supplier for similar services.

32.4 Subject to the above, no variation in or modification of the terms of the Contract shall be made except by written amendment signed by the parties.

33. Extensions of Time

33.1 If at any time during performance of the Contract, the Supplier or its subcontractors should encounter conditions impeding timely delivery of the Goods or completion of Related Services pursuant to GCC Clause 12, the Supplier shall promptly notify the Purchaser in writing of the delay, its likely duration, and its cause. As soon as practicable after receipt of the Supplier's notice, the Purchaser shall evaluate the situation and may at its discretion extend the Supplier's time for performance, in which case the extension shall be ratified by the parties by amendment of the Contract.

33.2 Except in case of Force Majeure, as provided under GCC Clause 31, a delay by the Supplier in the performance of its Delivery and Completion obligations shall render the Supplier liable to the imposition of liquidated damages pursuant to GCC Clause 26, unless an extension of time is agreed upon, pursuant to GCC Sub-Clause 33.1.

34. Termination

34.1 Termination for Default

(a) The Purchaser, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Supplier, may terminate the Contract in whole or in part:

- (i) if the Supplier fails to deliver any or all of the Goods within the period specified in the Contract, or within any extension thereof granted by the Purchaser pursuant to GCC Clause 33;
- (ii) if the Supplier fails to perform any other obligation under the Contract; or
- (iii) if the Supplier, in the judgment of the Purchaser has engaged in fraud and corruption, as defined in GCC Clause 3, in competing for or in executing the Contract.

(b) In the event the Purchaser terminates the Contract in whole or in part, pursuant to GCC Clause 34.1(a), the Purchaser may procure, upon such terms and in such manner as it deems appropriate, Goods or Related Services similar to those undelivered or not performed, and the Supplier shall be liable to the Purchaser for any additional costs for such similar Goods or Related Services. However, the Supplier shall continue performance of the Contract to the extent not terminated.

34.2 Termination for Insolvency.

(a) The Purchaser may at any time terminate the Contract by giving notice to the Supplier if the Supplier becomes MRC **rapt** or otherwise insolvent. In such event, termination will be without compensation to the Supplier, provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to the Purchaser

34.3 Termination for Convenience.

(a) The Purchaser, by notice sent to the Supplier, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.

(b) The Goods that are complete and ready for shipment within twenty-eight (28) days after the Supplier's receipt of notice of termination shall be accepted by the Purchaser at the Contract terms and prices. For the remaining Goods, the Purchaser may elect:

- (i) to have any portion completed and delivered at the Contract terms and prices; and/or
- (ii) to cancel the remainder and pay to the Supplier an agreed amount for partially completed Goods and Related Services and for materials and parts previously procured by the Supplier.

35. Assignment

35.1 Neither the Purchaser nor the Supplier shall assign, in whole or in part, their obligations under this Contract, except with prior written consent of the other party
